CERTIFICATION PROGRAMME: RISK MANAGEMENT IN BANKING (revised edition)

Risk management in banking has been transformed over the past decade, largely in response to regulations that emerged from the global financial crisis and the fines levied in its wake. But important trends are afoot that suggest risk management will experience even more sweeping changes in the next decade.

While the magnitude and speed of these changes is unlikely to be uniform across countries, the future undoubtedly holds more regulation—both financial and nonfinancial—even for banks operating in emerging economies.

If you are **Risk Manager, Auditor or Department Manager** with <u>a minimum of 3 years</u> <u>experience</u> in a banking environment, and wish to arm yourself with comprehensive skills in risk management, this programme is for you!

By earning the "Risk Management in Banking" certificate, you will signal to your employer that you are serious about risk management and that you can objectively demonstrate a standardized level of up-to-date industry knowledge, vital to protecting your institution.
